I agree to the following: The CLARANET is available on a 24 hour a day, 7 days a week non-guaranteed basis; and that all data on the system is informational only and is not advisory nor guaranteed to be accurate. Users are strongly encourage to "Shepardize" everything regardless of the creation date noted on a file. That passwords, e-mail messages received from CLARANET, or the computer files from CLARANET/CLARAWEB may not be distributed to others not noted on this form, and that if it is discovered that a subscriber has allowed a non-subscriber to use the CLARA system or have copies of computer files received from CLARANET, their subscription privileges may be suspended or revoked. Subscribers may access any of the file areas listed on the system's menus or retrieved from any listed database via the CLARA search engines, but may not attempt to enter any non-listed areas on the CLARA Internet Servers, or attempt to learn or use the passwords of other subscribers. Subscribers must be practicing criminal defense attorneys and assume all responsibility for ensuring that files downloaded or contributed are free from any virus or other damaging effects. Whether files received from the CLARANET & WEB Service carry a copyright notice or not, it is understood that those files may not be placed on any non-CPDA-hosted-internet-sites or storage devices intended for use by anyone as a commercial or non-commercial information service or data base unless previous written permission has been obtained from CPDA. I agree to comply with the rules, regulations and policies, as they may be amended from time to time, applicable to any services accessed through CLARANET or related services, and I agree that any violation of such rules, regulations or policies shall be cause for suspension or termination of services. It is understood that the internet network activity for the domains and IP blocks owned or administered by CPDA are monitored and logged on a regular basis for quality assurance and security purposes. Subscribers must maintain current CPDA membership. Subscribers may not be engaged in any law enforcement or prosecution activities of any kind, whether direct or indirect. It is understood that materials included on CLARANET that were prepared by the California Appellate Project or the California Office of the State Public Defender are intended for use only by persons involved in defense of death penalty cases, and that all rights to these materials are reserved. Subscribers may not make any CAP or OSPD materials available to anyone not directly involved in the defense of death penalty cases, and, in particular, to anyone involved in the prosecution of criminal cases or in any other law enforcement function. **CLARANET INFORMATION REGARDING CLARAWEB and the CLARANET List-Server**

**CLARANET List Server (claranet@cpda.org):** This service simply requires that you have a local internet account, such as that available through America On Line or Earthlink, etc. The CLARANET List Server is an e-mail distribution server that allows a CLARANET subscriber to forward e-mail messages to all other CLARANET subscribers. A subscriber sends one message addressed to [claranet@claranet.cpda.org](mailto:claranet@claranet.cpda.org) and that e-mail message will automatically be distributed to all other subscribers.. This service also acts as the CPDA "pipeline" by which CLARANET subscribers receive CPDA news, training program flyers, product order forms and product information, membership and other accounting replies.

**CLARAWEB.** The web service is a private "web site" accessed only by CLARA Internet subscribers, (not visible to the public). The web server includes dozens of web pages devoted criminal defense practice information, legislative efforts, amicus activity, message boards, "chat rooms", a products catalog/orders search page, and numerous pages listing practice files that will automatically "download" to your computer when you "click" on their file names. The CLARA Web Server also features our very powerful **CLARASEARCH** program that enables subscribers to perform keyword searches, via the internet, on over 9,500 criminal defense-related files including case digests, briefbanks, motions, research articles, the evidence, penal, vehicle, health & safety and other criminal practice codes. Additionally, the CLARA Web Server now provides the opportunity to obtain more than 100 hours of MCLE self-study credits using **RealAudio Player** for web browsers.
