The Public Defender oversees a team of 14 total staff and a \$3.8 million budget, serves as a key legal advisor to County leadership, and guides case strategy, staff development, and the continuous improvement of policies, procedures, and service delivery. # THE PUBLIC DEFENDER'S OFFICE & PARTNERSHIP WITH HHSA

## THE PUBLIC DEFENDER'S OFFICE IS A MISSION-DRIVEN LEGAL DEPARTMENT

dedicated to providing high-quality, client-centered representation for the community's most vulnerable members. The Office represents indigent adults and juveniles charged with criminal offenses and provides legal services in civil conservatorship and Assisted Outpatient Treatment (Laura's Law/AOT) matters. Grounded in constitutional principles, the Public Defender's Office approaches its work with respect, dignity, and without judgment, recognizing the complex social, economic, and behavioral health factors that often intersect with the justice system. Through collaboration with community partners and County agencies, the Office strives not only to protect clients' legal rights in court but also to address underlying needs, promote fairness, and contribute to a more just and effective local justice system.

The Nevada County Public Defender's Office is known for its zealous client advocacy and, through its unique alignment with Health and Human Services, has become a leader in reform and system change that benefits both clients and the broader community. The Office prioritizes diversion and connection to supportive services and has partnered with Public Health as a Narcan distributor, embedded a housing case manager within the defense function, and plays an active role in collaborative courts. These efforts were recognized with the 2025 CSAC Achievement Award for the Incompetent to Stand Trial Response Team, honoring the Office's innovative, cross-agency work to improve outcomes for patients with behavioral health needs. This recognition reinforces the Office's dual commitment to constitutionally mandated representation and building a more just, effective justice system.

## THE JOB

**R**EPORTING TO THE COUNTY EXECUTIVE OFFICER, the Public Defender plans, organizes, and directs all activities of the Public Defender's Office and may personally handle complex criminal defense cases as needed. The position oversees a dedicated team of 14 total staff, manages a \$3.8 million budget, and serves as the County's principal authority on public defense matters.

### Key Responsibilities Include:

- Leading and managing the Public Defender's Office, including staff supervision, mentoring, training, and professional development
- Establishing departmental goals, policies, procedures, operational standards, and outcomes
- Preparing, administering, and advocating for the department budget and resource needs
- Managing and monitoring attorney caseloads to ensure high-quality, timely legal representation
- Reviewing complex or high-impact cases and advising staff on legal strategy, case management, and courtroom practice
- Appearing in court as needed to represent clients and support office operations
- Serving as a senior legal advisor to County leadership and the Board of Supervisors on public defense matters
- Working in close partnership with the Health and Human Services Agency (HHSA) to align legal advocacy with behavioral health, housing, and social service resources
- Participating in shared leadership and cross-departmental initiatives that support diversion, treatment-based solutions, and whole-person approaches to justice
- Coordinating regularly with HHSA leadership and program staff to strengthen system integration and improve outcomes for shared clients
- Building and maintaining strong working relationships with the courts, District Attorney, law enforcement, community-based organizations, and justice system partners
- Connecting clients to services and alternatives when appropriate, while remaining a firm and trusted advocate in the courtroom.

# THE IDEAL CANDIDATE

**T**HE IDEAL CANDIDATE IS A SEASONED PUBLIC DEFENSE PROFESSIONAL with substantial courtroom experience who brings a strategic, solutions-focused approach to serving vulnerable populations and advancing effective public defense systems. They are a proven organizational leader and effective communicator, capable of establishing clear expectations, mentoring and supporting a developing management team, and fostering accountability across the office. The successful candidate exercises sound judgment in fast-paced and evolving environments and is comfortable making well-reasoned decisions, while remaining adaptable and open to differing perspectives. They are professional, empathetic, and composed, effectively navigating complex interpersonal dynamics and building trust through consistency, follow-through, and reliability. With strong knowledge of criminal law, trial practice, and public defense administration, as well as an understanding of diversion, treatment-based approaches, and system reform, the Public Defender aligns staff, processes, and partnerships to strengthen performance and client outcomes. Through ongoing collaboration with courts, justice system partners, the Health and Human Services Agency, and community-based organizations, the role advances high-quality, mission-driven public defense services for the community.

**Sensitivity:** Demonstrates empathy, cultural awareness, and respect when working with clients, staff, and partners, while also serving as a strong and effective legal advocate who fights for clients' rights and interests within the justice system.

**Visioning:** Articulates a clear and compelling direction for the Public Defender's Office, balancing immediate operational needs with long-term system improvement, innovation, and reform.

**Political Acumen & Relationship Building:** Effectively navigates the public-sector environment by building trusted relationships with the Board of Supervisors, courts, justice system partners, the Health and Human Services Agency, and community stakeholders to advance shared goals.

**Team Development:** Builds, mentors, and supports a high-performing team by fostering accountability, professional growth, collaboration, and a shared commitment to excellence in public defense.
